

**FRENCH VAT / TVA REFUND INFORMATION
CARTES & IDENTIFICATION 2009 CONGRESS**

Dear delegates,

According to the French and European Tax Legislation, COMEXPOSIUM, the organiser of CONGRES CARTES & IDENTIFICATION, has to charge the French VAT on its services.

Foreign delegates (EU or non-EU) are entitled, under certain conditions, to a refund of the VAT amounts paid.

In order to improve and to speed up the French VAT refund procedure, COMEXPOSIUM and TEVEA International, the official tax agent of the congress, are pleased to offer you a simplified refund procedure, by following the 3 steps below:

- ❶ With your **authorisation (doc 1)** COMEXPOSIUM forwards your original invoice, the only document enabling you to obtain the refund, directly to TEVEA International.
- ❷ You fulfil and sign the **appointment form (doc 2)** authorising TEVEA International to proceed your VAT claim and your **company details (doc 3)**.
French fiscal authorities also request an **original VAT certificate** of your company for EU delegates (this VAT certificate is issued by your local VAT collection office; make sure that your intra-community VAT ID number appears on the certificate) or an equivalent document for non EU delegates (copy of tax certificate, registration certificate, copy of by laws,...).
- ❸ TEVEA INTERNATIONAL will reclaim the VAT amounts. You will receive the refund amount in a period of **7 days**, after submission to French fiscal authorities, thanks to our QuickRefund service. The QuickRefund fees are 60 € of basic fee + 12% of the VAT amount.

We thank you very much for sending the enclosed authorisation by fax or mail to TEVEA International. During the Congress our team will be at your disposal for getting your documents and settle all the details. By this way you will receive a very fast and easy refund and you avoid the risk of a loss of the original invoice, so a loss of your VAT amount.

We hope to meet your agreement and remain at your entire disposal for any further information you may require. In the meantime we remain,
